FAILURE TO FILE A REPORT AS REQUIRED WILL RESULT IN A DELINQUENT PENALTY OF 5% PER MONTH OR FRACTION THEREOF AND 10% PER MONTH FOR EACH FOLLOWING MONTH. ADDITIONALLY A DELINQUENT INTEREST OF 8% PER ANNUM OF THE DELINQUENT TAX WILL BE ASSESSED AND DUE.

IF PENALTY AND INTEREST IS INCORRECTLY CALCULATED YOU WILL BE INVOICED FOR THE DIFFERENCE WHICH WILL BE IMMEDIATELY DUE AND PAYABLE.
