BUSINESS LICENSE APPLICATION

NOTICE: Adak City Ordinance Chapter 4.08 details the application, exemptions, and conditions of business licenses. If the applicant or anyone with an ownership interest of more than 10% in the applicant is delinquent in sales tax or utility charges assessed by the city, the application will be forwarded to the City Council, who reserves the to review any application. The City Council may approve the application with or without conditions, including, but not limited to, the posting of security in the form of surety bonds, letters of credit or certificates of deposit, payable to the City. The City Council may deny the application. If the applicant is rejected by the City Council, written reason will be given to the applicant within 30 days from the date the application is submitted.
